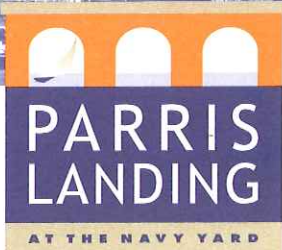

2010 POOL RULES AND REGULATIONS**

Use of the swimming pool is restricted to **RESIDENTS** and their guests only. All guests must be accompanied by their "host" and are only permitted to stay in the pool area while their "host" is present. A photo pool pass must be presented to the lifeguard each time you enter. Pets are not permitted in the pool area.

1. **POOL DATES AND HOURS:** The pool will be open May 29, 2010 – September 6, 2010.  
Weather permitting; the lifeguard will be on duty:  
Daily: May 29, 2010 – September 6, 2010 9:00am – 9:00pm  
Pool closes promptly at 9:00pm. No swimming is allowed after 9:00pm.  
Extended Hours – No Lifeguard on duty:  
Weekdays ONLY – May 29, 2010 - September 6, 2010 Sunrise – 9:00am (lifeguard on duty as of 9am)  
Weekdays ONLY - September 7, 2010 – September 24, 2010 Sunrise – Sunset  
**Pool is closed on weekends September 11, 2010 – September 19, 2010 as no lifeguard is on duty.**  
**When no lifeguard is on duty:**  
Use is restricted to Monday – Friday daylight hours only.  
Adult should accompany children under age 16.  
Adults should not swim alone.  
**All swimmers, swim at your own risk.**
2. The lifeguard's duties are to supervise all matters of safety in the pool area and is authorized and required to enforce all the Rules and Regulations pertaining to the pool area.
3. An adult should accompany persons under 16 years of age. Parent or responsible guardian must watch their children closely whenever they are near or in the water, regardless of their age or swimming ability.
4. The Association, Management Company and employees are not responsible for injuries or accidents incurred through the use of the pool, nor are they liable for any losses arising out of the use of the pool.
5. A maximum limit of two guests per unit will be allowed.
6. The pool is NOT available for private parties.
7. No smoking, alcohol, or glasses containers will be permitted in the pool area.
8. Residents and guests must shower before entering the pool. All persons must wear proper swimming attire. All individuals should wear cover-ups and footwear when going to and from the pool area.
9. Children not toilet trained should wear proper swimwear protection to avoid accidents in the pool.
10. No tables, chaise lounges, furniture or other equipment may be removed from the pool or patio areas at any time.
11. Chairs cannot be reserved. Seating is limited to first come first serve. Please do not put a towel down in the morning if you do not intend to arrive until the afternoon.
12. Any radio, television, cd or tape player or similar device must be kept well away from the waters edge, used with an earphone and must not disturb other people.
13. No bicycles, wagons, ect. are permitted on the pool deck.
14. Because artificial flotation devices may interfere with or disrupt the lifeguard's view of the water, or may provide a false sense of security for the user, they are prohibited from use. Prohibited items include, but are not limited to, inner tubes, rafts and non Coast Guard approved water wings or life jackets. **12(a)** Exception for persons with disabilities:
  - If a pool patron requires the assistance of a flotation device as an aid for a disability, that patron must notify the Pool Attendant on duty of the need for such a device upon each visit to the pool.
15. No playing around pool drains.
16. No diving, running, pushing, screaming or obnoxious disturbances are permitted in the pool area.

**BBQ Area:**

1. BBQ area will open at 9am and close promptly at 10pm. All residents must enter/exit through gate using key fob. Gate between pool and BBQ area is to be locked at all times.
2. Be aware that sound travels and exercise extreme caution to keep voices at a low level so as not to disturb your fellow residents. If noise complaints are received you will be asked to leave the BBQ area.
3. As space is limited, please exercise courtesy to fellow residents by removing all food and utensils immediately after cooking.
4. Please clean out the barbecue grills after each use and place all refuse in the containers provided.
